## School Facilities

### Summary of Most Recent Site Inspection

---

LPS Richmond operates a closed campus in space provided in part by the West Contra Costa Unified School District (WCCUSD) under Proposition 39. LPS Richmond moved over the Winter break to 215 S. 12<sup>th</sup> St. adjacent to the Nystrom Elementary Campus. This campus is comprised of 22 classrooms, 4 offices, 2 computer labs, a media library, and a multi-purpose room. The WCCUSD has informed LPS that the school building is in compliance with applicable safety and building codes. LPS Richmond also maintains a portable campus at 715 Chanslor Avenue.

Our campus is largely modernized and in good condition. The main campus is situated around a large central quad that features basketball courts, a small soccer area, a shade structure, outdoor seating, and game tables. LPS Richmond employs an independent contractor to provide janitorial services during non-school hours.

### Repairs Needed

The new campus has some issues with ponding and is awaiting the completion of the project punch list.

### Corrective Actions Taken or Planned

---

Request to WCCUSD to address ponding issues. WCCUSD to complete punchlist in February 2009. Ongoing maintenance throughout campus including paint, planting, updating technology infrastructure.

Either the SAC or the appropriately configured subcommittees of the SAC will constitute a School Site Committee (SSC) or English Language Advisory Committee (ELAC) when LPS Richmond receives categorical funds with these requirements.*

**Safety, Cleanliness & Adequacy of the Facilities:** LPS Richmond operates a closed campus in space provided in part by the West Contra Costa Unified School District (WCCUSD) under Proposition 39. LPS Richmond moved over the Winter break to 215 S. 12<sup>th</sup> St. adjacent to the Nystrom Elementary Campus. This campus is comprised of 22 classrooms, 4 offices, 2 computer labs, a media library, and a multi-purpose room. The WCCUSD has informed LPS that the school building is in compliance with applicable safety and building codes. LPS Richmond also maintains a portable campus at 715 Chanslor Avenue.

Our campus is largely modernized and in good condition. The main campus is situated around a large central quad that features basketball courts, a small soccer area, a shade structure, outdoor seating, and game tables. LPS Richmond employs an independent contractor to provide janitorial services during non-school hours.

**Degree to which buildings and grounds provide adequate space for teaching and learning (classroom space, playground space & staff space):** Our facility meets our needs for classroom space. We have arranged to use adjacent playing fields, gymnasium and multi-purpose space owned by the Richmond Parks and Recreation Department.

**Condition of restrooms, floors, walls, roof, electrical and plumbing systems:** The facilities at the 12<sup>th</sup> St. campus are either new or recently renovated and are in good condition. Our portable buildings on Chanslor Avenue were new when installed in 2003 and all systems are in good condition.

**Suitability of the facility as a learning environment including, but not limited to, lighting, heating, cooling and noise negation; the condition of the school's fire alarm system; the condition of the school's technology infrastructure:** Noise negation is not an issue. The School's fire alarm system functions properly and is regularly maintained. LPS Richmond has also invested considerable funds to create and maintain an innovative technology infrastructure including a mobile cart with 16 laptops, a printer, and wireless network access; a computer lab with 24 student thin clients; two mini-labs of dedicated Read180 computers and an Academic Numeracy Computer Lab.

**Efforts to keep the building and grounds clean, free of litter and graffiti, etc.:** The School employs an independent contractor that provides janitorial services. They are responsible for keeping the buildings and grounds clean and free of litter and removing graffiti when necessary. In addition, students are periodically assigned to "community service/ work detail" where assignments often include helping to keep clean the classrooms and open space. Volunteer beautification days are also coordinated by dedicated staff and school community.

**Efforts to ensure the school facilities are in good repair and safe for students and staff:** WCCUSD provides deferred maintenance services for facilities used by LPS Richmond at the 12<sup>th</sup> St Campus. The School retains the services of an independent handyman when necessary for ongoing minor maintenance. The Chanslor Avenue campus is maintained largely by the portables leasing company.

**21<sup>st</sup> Century High School ASSETs Program:** *LPS Richmond received a grant from the 21<sup>st</sup> Century High School After School Safety and Enrichment for Teens (ASSETs) Program. This grant provides us an opportunity to establish a variety of before- and after-school enrichment programs that provide academic support, CAHSEE prep, college prep, mentoring, tutoring, homework assistance, enrichment opportunities in the arts and physical fitness opportunities for all our students. This grant also affords us the opportunity to provide greater support and services to our families (e.g. computer literacy, workshops, job training, English as a second language). We currently offer the following classes/activities:*

*In addition, LPS Richmond offers students a number of sports options each year. These include boys and girls basketball, boys and girls soccer, boys' baseball, girls' volleyball and girls' softball.*

**After School Office Hours:** *Students needing additional instruction and skill development in literacy and numeracy, or students needing further support to pass the California High School Exit Exam (CAHSEE) are enrolled in an additional class after school that meets for a minimum of 3 hours weekly.*

**Community College Courses:** *LPS Richmond has developed concurrent enrollment relationships with local community colleges. Currently, there is a class called "Psychology of La Raza" being offered to LPS Richmond students. Our students will continue to have the opportunity to enroll in a variety of courses that provide additional enrichment, increased academic support or credit recovery.*

**Cyber High:** *Cyber High is a comprehensive "electronic high school" that is available to students at LPS Richmond. Accessible via the internet, the Cyber High curriculum is aligned with the California content standards, meets the admission requirements for the UC/CSU system, and is accredited through the Fresno Unified School District. Students at LPS Richmond enroll in Cyber High courses for acceleration, enrichment or credit recovery.*

**Revolution Foods Food Services:** *LPS Richmond has secured Revolution Foods as our meal provider for students. Revolution Foods delivers healthy, fresh, organic meals (breakfast, lunch, after school snacks) on a daily basis to LPS. In addition, Revolution Foods provides our students ample opportunities for learning about healthy eating and nutritious food.*
